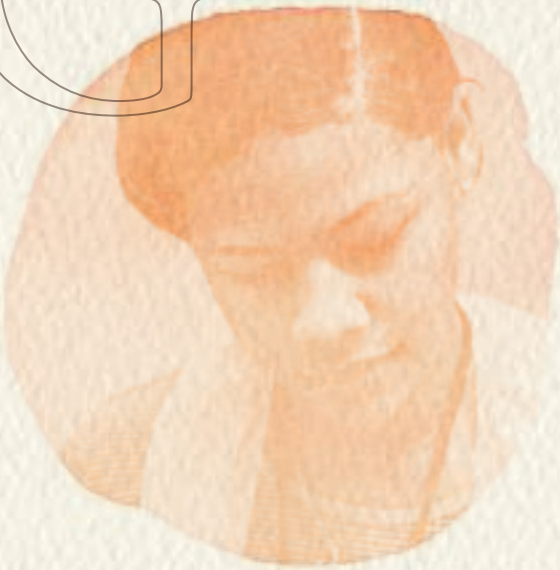

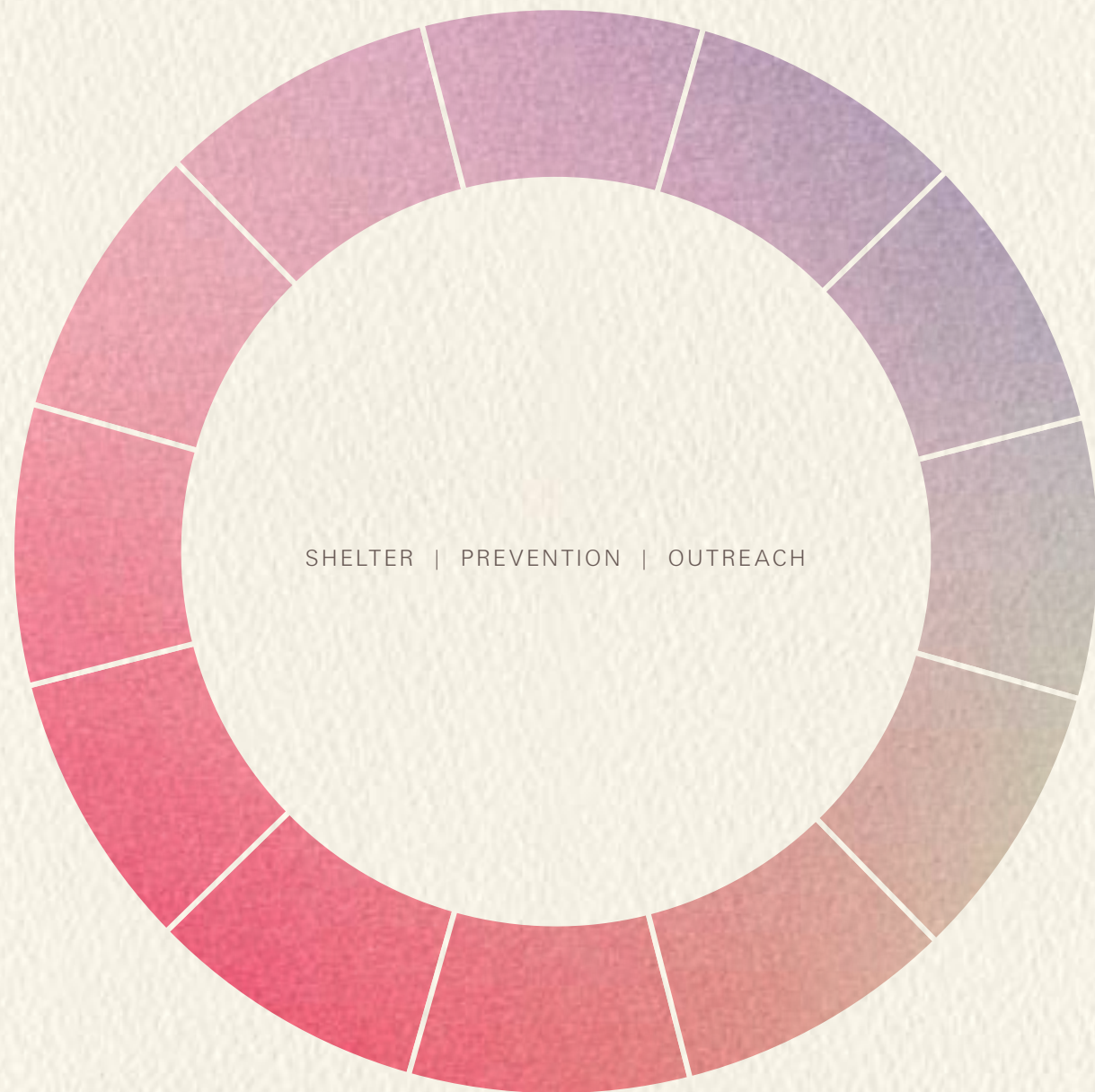


Our Mission

ALTERNATIVES FOR GIRLS HELPS HOMELESS AND HIGH-RISK GIRLS AND YOUNG WOMEN AVOID VIOLENCE, TEEN PREGNANCY, AND EXPLOITATION AND HELPS THEM EXPLORE AND ACCESS THE SUPPORT, RESOURCES, AND OPPORTUNITIES NECESSARY TO BE SAFE, TO GROW STRONG, AND TO MAKE POSITIVE CHOICES IN THEIR LIVES.



H I G H L I G H T S



THE AFG SHELTER:

Provides counseling to residents and helps them acquire the skills they need to lead independent, productive and fulfilling lives.

Last year:

- AFG's Shelter provided 9,825 nights of care to 139 homeless young women and their children.
- 70% of the young women in the Transition to Independent Living Program were either enrolled in school, working, or both.
- 100% of AFG Aftercare participants reside in safe and stable housing.

THE AFG PREVENTION PROGRAM:

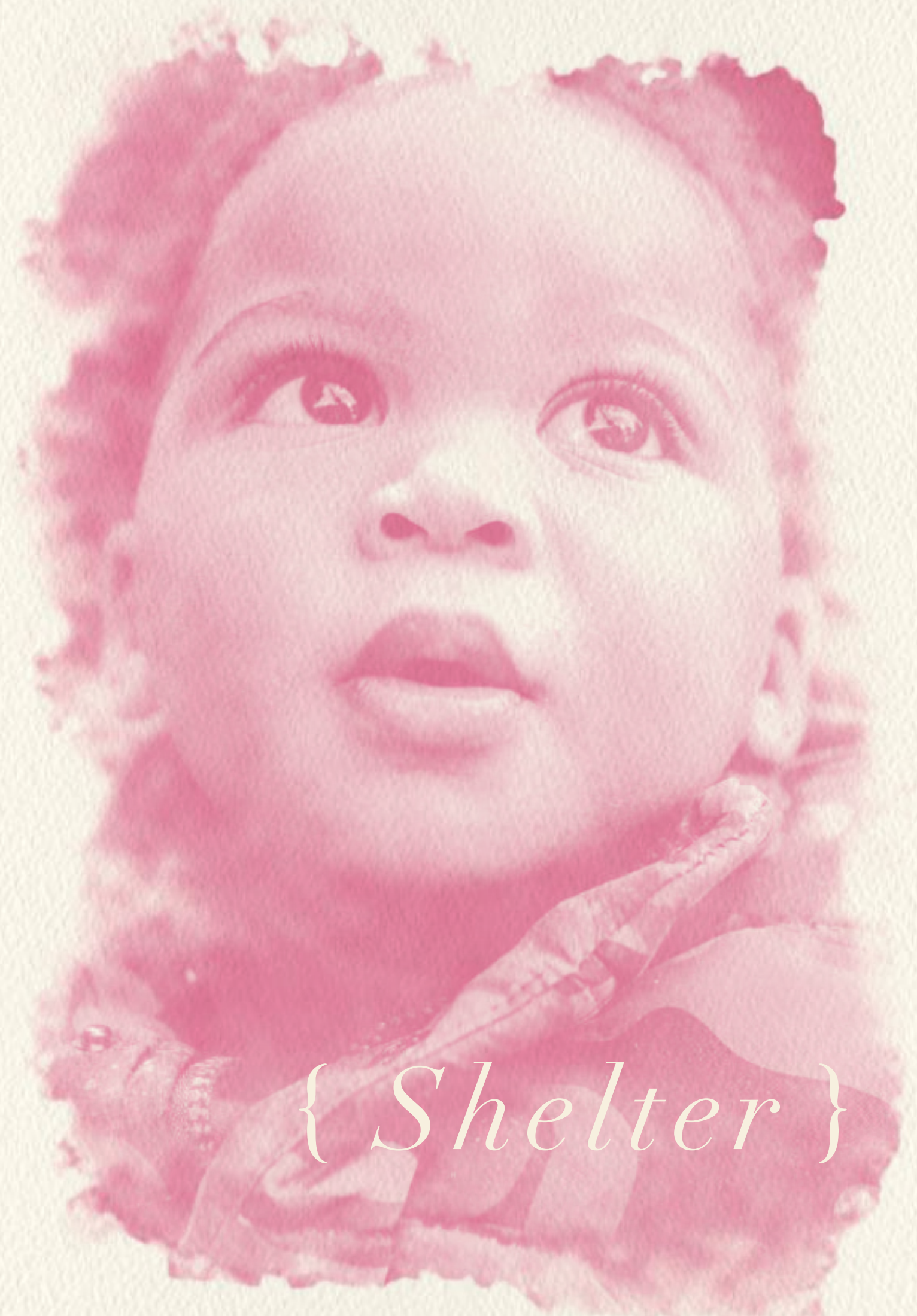
Works with girls ages 4-18 at risk of teen pregnancy, gang involvement, abusing drugs or alcohol and school truancy. Last year:

- 100% of participants in after-school workshops and the Rise N' Shine summer camp remained drug free.
- For the 18th year in a row, 100% of the high school seniors in AFG's Prevention Program graduated from high school.
- 100% of participants in after-school workshops and the Rise N' Shine summer camp avoided early pregnancy.

THE AFG OUTREACH PROGRAM:

Helps teens and women engaging in high-risks activities understand the risks and transition to safe choices and healthy lives. Last year:

- 100% of New Choices participants (of 6 months or more) made significant progress towards or completed goals of recovery, employment, and/or housing.
- Our Resource Center provided resources to 1,465 contacts. During this time, individuals were connected to services at AFG, or were referred to additional homeless shelters, after-school programs, and health care services.
- 100% of participants in the Peer Education program avoided early pregnancy.

DEAR FRIENDS,

Alternatives For Girls is pleased to present our annual report for the '17-'18 year. In this report, we are celebrating hope. Every day at Alternatives For Girls, hope is created for girls and young women. In our shelter, a safe and positive place to stay for girls and young women who have run out of options creates hope for a brighter future. In our after-school programs, support for girls to focus on their education, improve their grades, and graduate from high school creates hope for unlimited possibilities. During street outreach, compassion and safe alternatives for those involved in sex work or are victims of human trafficking create hope that tomorrow will be better.

Without your support, none of this would be possible. This year, you have helped hundreds of girls and young women leave behind homelessness, violence, and exploitation. You have helped them find safe housing, graduate high school, and access a whole new world of possibilities. You have helped provide hope.

Within the past year, we have begun implementing a groundbreaking "Housing First" model for youth experiencing homelessness; the first of its kind in the region. Our Asset-Building Project for Education and Opportunity program allowed 33 young women to save money for college, go on local and out-of-state college tours, and learn about new career opportunities. We've also facilitated educational intervention programs for those girls and young women facing "soliciting" charges, and continued to support victims of human trafficking by participating in sting operations as victim advocates to ensure the safety and recovery of trafficking survivors.

In our ever-changing economy, we also suffered setbacks this year in the form of losing two long-standing grants, due to shifting priorities for federal funding across the country. Because of our successful four-year "Securing AFG's Future" campaign, in which countless individuals, corporations, and foundations helped us build up \$1.7 million in reserve funds, we were able to keep our core programs intact, while we continued to prepare for future growth. And, because of your support, we will still be here to help homeless and high-risk girls and young women make plans for their futures. Over the next year, we plan to grow our programs in new ways, as we research and adjust to the changing needs of those we serve. Our innovative long-term program and financial planning, along with our inspired volunteer leaders and donors, positioned us to be recognized with Crain's coveted "Best-Managed Nonprofit" award in December.

In the following pages, you will see the impact of your support through the annual statistics that reflect the work we do every day, as well as the latest chapter in the financial story of the agency. Thank you for your support in ways both big and small this past year. Your gifts of time, talent, and treasure have made a lasting impact – from mentoring a girl who is preparing for college, to donating clothing for a young woman looking for a fresh start, to sharing our story with your friends and family, and everything in between. We appreciate all that you do and are grateful for this opportunity to report back the impact you've made and the achievements of the girls and young women we serve.

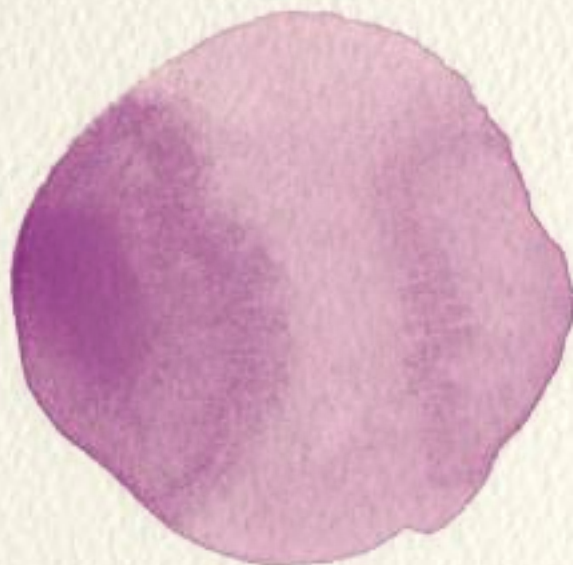
