THE PROGRAM BEGINS WITH SAFE HOUSING AND SUPPORTIVE SERVICES TO THE RUNAWAY, EMERGENCY SHELTER, AND TRANSITION TO INDEPENDENT LIVING PARTICIPANTS. THE PROGRAM PROVIDES RESIDENTIAL SERVICES FOR A MAXIMUM OF 21 MONTHS. DURING THIS TIME, YOUNG WOMEN CAN TRANSITION INTO THE ORGANIZATION'S INDEPENDENT LIVING PROGRAM, WHERE THEY ARE SUPPORTED IN DEVELOPING THE NECESSARY LIFE SKILLS TO ENABLE THEM TO LIVE INDEPENDENTLY. INDIVIDUAL, GROUP, AND FAMILY COUNSELING AND SUPPORT, AS WELL AS PARENTING SKILLS (WHEN APPLICABLE), EDUCATION AND EMPLOYMENT SKILLS AND REFERRALS, AND A STRUCTURED COURSE OF INDEPENDENT LIVING SKILLS TRAINING, ARE PROVIDED. THESE SERVICES
