THE PROGRAM BEGINS WITH SAFE HOUSING AND SUPPORTIVE SERVICES TO THE RUNAWAY, EMERGENCY SHELTER, AND TRANSITION TO INDEPENDENT LIVING PARTICIPANTS. THE PROGRAM PROVIDES RESIDENTIAL SERVICES FOR A MAXIMUM OF 21 MONTHS.
