**NANETTE LEE REYNOLDS, ED.D.** has worked with three governors to further the course of civil rights in Michigan. Dr. Reynolds was appointed director of the Michigan Department of Civil Rights in 1993.

**JOANNE START** is Managing Director-Michigan Market, BPI group, a global human resource consulting and executive coaching firm.

The late **MAUREEN A. FAY, O.P., PH.D.** worked to improve education as President of the University of Detroit Mercy and as a member of the Dominican Sisters of Adrian, Michigan. She was the first female president of a Jesuit university.

**PAMELA RODGERS** started her career with Ford Motor Company as a financial analyst eventually building her business Rodgers Chevrolet, Inc. in Woodhaven, Michigan. She has served on AFG's Board.

**JULIE FISHER CUMMINGS** is a strong advocate for responsible policies on health, education, and philanthropy on behalf of underserved and marginalized children and families. She founded the Lovelight Foundation and serves on multiple non-profit boards.

**THE HON. DENISE PAGE HOOD, JD** was nominated by President Bill Clinton and confirmed by the Senate in 1994, becoming the first African-American in 13 years to join the Eastern District of Michigan bench.

**GAIL PERRY-MASON** has climbed the corporate ladder from receptionist to Senior Director of Investments of Oppenheimer & Co., Inc. Ms. Perry-Mason has mentored many young women who are now leaders in the financial industry.

MARILYN FRENCH HUBBARD, PH.D. is the Founder of the National Association of Black Women Entrepreneurs, Inc. and is the founding Vice President of the National Association of Women Business Owners (NAWBO), Michigan Chapter.

**ANN H. HOAG** is a retired Senior Director of Leadership Programs for the Detroit Regional Chamber. Ms. Hoag led Leadership Detroit, the Leadership Policy Conference, the chamber's diversity initiatives, and headed the Mackinac Conference.

**ALEXA CANADY, M.D.** retired as Chief Neurosurgeon of Children's Hospital of Michigan and Vice Chair of Neurosurgery at Wayne State University. In 1981, Dr. Canady was the first female and the first African American neurosurgeon.

MARY KRAMER is a seasoned expert with nearly 30 years of reporting and management experience. In 2012, she was named Group Publisher at Crain Communications, supervising Crain's Cleveland business along with Detroit. Throughout her career, Ms. Kramer has served on various non-profit boards.

The late **GUADALUPE G. LARA, LMSW** dedicated 27 years to advocating for families at Children's Hospital of Michigan until she retired in 2006. Five different Michigan governors named Ms. Lara to lead boards and commissions based on her advocacy on behalf of the underserved and Hispanic issues.
